Our Cookies Policy explains what cookies are, how we use cookies, how third-parties we may partner with may use cookies on the Service, your choices regarding cookies and further information about cookies.

What are cookies

Cookies are small pieces of text sent by your web browser by a website you visit. A cookie file is stored in your web browser and allows the Service or a third-party to recognize you and make your next visit easier and the Service more useful to you.

Cookies can be "persistent" or "session" cookies.

How Grandis Securities Ltd uses cookies

When you use and access the Service, we may place a number of cookies files in your web browser.

We use cookies for the following purposes:

- verifying your identity and detecting which country you are located in
- Determine the browser and settings you are using, to provide optimised content
- Understand the way you navigate through websites, so the Company can make improvements
- Help site owners and third-party advertisers tailor content to your preferences.

You can choose to decline cookies via your browser's privacy settings but please note that this may have a negative impact on your browsing experience and particularly if these are declined across all websites.

What types of cookies do we use?

There are five main types of cookies:

- **Strictly necessary cookies** – These cookies are essential to enable you to login, navigate around and use the features of our Service, or to provide a service requested by you (such as your username). We do not need to obtain your consent in order to use these cookies. These cookies can be used for security and integrity reasons.
- **Functionality cookies** – These cookies allow our Service to remember choices you make (such as your language) and provide enhanced and personalized features. The information these cookies collect remains anonymous and they cannot track your browsing activity on

Third Party Websites. For example, these cookies are used for authentication (to remember when you are logged-in) and support other features of our Service.

- Performance cookies – These cookies collect information about your online activity (for example the duration of your visit on our Service), including behavioral data and content engagement metrics. These cookies are used for analytics, research and to perform statistics (based on aggregated information).
- Targeting cookies or advertising cookies – These cookies are used to deliver tailored offers and advertisements to you, based on your derived interests. They can also be used to limit the number of times you see an advertisement as well as help measure the effectiveness of the advertising campaign. They are usually placed by our advertisers and provide them insights about the people who see and interact with their ads, visit their websites or use their app.

Third-party cookies

In addition to our own cookies, we may also use various third-parties cookies to report usage statistics of the Service, deliver advertisements on and through the Service, and so on.

These cookies are used by third parties and mostly by social media websites like Google+, Facebook or YouTube. Third Party cookies allow us to offer you easy ways to share our content throughout your social media.

You can disable the use of these cookies through your browser's privacy settings but please do note that this will also disable all the functions described above.
